

#### Knowledge Exchange: In Theory, In Practice

Evidence Exchange Network (EENet)

Led by Evidence Exchange Network (EENet), this preconference workshop will focus on the key skills and capacities required to carry out knowledge exchange (KE) activities—and to bring evidence to action. Participants will gain an understanding of KE theory, and will learn how to use different KE planning templates to guide and spark KE work at all stages of a project and to support evidence-informed decision making. They will engage in hands-on practice with KE planning, and will also be exposed to different vehicles for KE—from traditional products like webinars to more innovative outputs, like infographics, comic books, and online communities. Participants will also acquire a sense of what KE looks like on the ground; drawing on EENet's own experiences in Ontario's mental health and addictions system, presenters will situate KE within the context of projects that are currently underway and implementing practices in the system, including Systems Improvement through Service Collaboratives and the Drug Treatment Funding Program.

- Practical: how to use a KE planning template; an overview of innovative KE products and approaches

<u>Evidence Exchange Network</u> (EENet) is a mental health and addictions knowledge exchange network that connects stakeholders across Ontario. The EENet community includes researchers, clinicians, decision-makers, service providers, system planners, policymakers, persons with lived experience, and families. The network promotes the use of research evidence in decision-making, develops targeted knowledge translation products and tools, and supports interactive exchanges.

#### How to conduct a meta-analysis

Kelly Babchishin, PhD; Leslie-Maaike Helmus, PhD

Meta-analysis has become the gold standard for summarizing research in psychology. However, different researchers have conducted meta-analyses examining the same research question and produced different answers. This demonstrates that meta-analyses range in quality and require considerable forethought and conscientiousness in finding, coding, and analysing effect sizes. The purpose of this workshop is to teach participants how to conduct a comprehensive meta-analysis, including establishing inclusion criteria and searching for studies, selecting and coding the best effect size (including transforming data to different effect size metrics), aggregating the findings, and conducting moderator analyses. This workshop is applicable to people wishing to conduct their own meta-analyses, or simply to become more critical consumers of published meta-analyses. Participants will learn the basic concepts behind the statistical formulae and how to run the analyses in SPSS and Comprehensive Meta-Analysis (SPSS syntax for analyses is included for workshop participants). Both fixed-effect and random-effects meta-analyses techniques will be covered. Although the skills are applicable to an array of psychological research questions, most of the examples provided will focus on research questions in criminal justice psychology.

Dr. Kelly Babchishin is a Banting postdoctoral fellow (CIHR) at the Institute of Mental Health Research (Royal Ottawa Hospital, University of Ottawa) and the Department of Medical Epidemiology and Biostatistics (Karolinska Institutet, Stockholm, Sweden). Her current research involves identifying causal candidates for the onset of sexual and non-sexual violent offending behaviours. Other research interests include change in sexual offending behaviours across the lifespan, pedophilia, incest, and online sexual offenders. Dr. Babchishin has published over a dozen meta-analyses published in peer-reviewed journals and has experience assisting and providing consultations on meta-analyses. Kelly has taught a graduate-level statistics course on meta-analysis at Carleton University and several one-day workshops on meta-analysis with Leslie-Maaike Helmus.

Leslie-Maaike Helmus is a graduate student in forensic psychology at Carleton University in Ottawa, Ontario, Canada, and a researcher with the Forensic Assessment Group. Her research interests focus on the assessment and treatment of sexual offenders. She has published roughly a dozen meta-analyses and regularly provides consultation and assistance for meta-analyses. Leslie-Maaike has taught a graduate-level statistics course on meta-analysis at Carleton University and several one-day workshops on meta-analysis with Dr. Kelly Babchishin. She is a certified trainer for two actuarial risk assessment scales and has received numerous grants and academic awards including the Association for the Treatment of Sexual Abusers Pre-doctoral Research Grant, the Joseph-Armand Bombardier Canada Graduate Scholarship, and the Athreya-Haritha Graduate Scholarship. Leslie-Maaike has also been involved on the Executive boards of both the Criminal Justice Section of the Canadian Psychological Association and the Association for the Treatment of Sexual Abusers.

#### Mapping uncharted waters in the science of implementation Melanie Barwick, PhD, CPsych

Scientific innovations and new knowledge often languish in academic journals or percolate within contained scientific communities, greatly limiting real world impacts they may have across many sectors, including health, education, and human services more generally. The last decade has seen an emergence of a new field of Implementation Science that aims to address how best to share what we learn with varied audiences in hope of attaining greater impacts. This lecture will review what we have learned so far in our journey of bringing research evidence to real world application, and identify what we have yet to learn.

Melanie Barwick (PhD, CPsych) is a Senior Associate Scientist and Head of the Community Health Systems Resource Group in the Department of Psychiatry at SickKids. She is affiliated with the SickKids' Learning and Research Institutes, and is Scientific Director of Knowledge Translation for the Child Health Evaluative Sciences program. She is Associate Professor in the Department of Psychiatry and at the Dalla Lana School of Public Health at the University of Toronto. Her focus is implementation science, studying innovative health knowledge translation strategies and implementation of research to practice. Her work in education and professional development includes the development of the Scientist Knowledge Translation Training program (SKTT) and the Knowledge Translation Professional Certificate (KTPC). Her program of research in implementation science and knowledge translation explores empirically supported approaches, measures and tools to support the implementation of evidence-based practices in mental health, education, health, and global health context.

He is also Adjunct Professor of Global Health, Department of Global Health and Population, Harvard T.H. Chan School of Public Health. His research focuses on how to support the use of research evidence in health policymaking, both in high-income countries like Canada and in a broad range of countries internationally.
