
Everyone has mental health and will experience challenges regarding their mental well-being, but not everyone will experience a mental illness. Mental illness indirectly affects all Canadians at some time either through their own experience, or that of a family member, friend or colleague.

Mental illness and addiction affects people of all ages, education, income levels, and cultures; however, systemic inequalities such as racism, poverty, homelessness, discrimination, colonial and gender-based violence, among others, can worsen mental health and symptoms of mental illness, especially if mental health supports are difficult to access.



We all know the world is changing fast.

Recent polling from Mental Health Research Canada tells us that fully 24% of Canadians report feeling exhausted and burned out – on top of that, people who experience economic uncertainty report higher anxiety and depression, higher rates of thoughts about suicide, and substance dependency. Waypoint is located in the fastest-growing region in the province—and one of the fastest-growing in the country. This rapid growth is amplifying challenges, particularly for older adults.



Giving Options

Gift in Your Will

You can name Waypoint to receive an amount, percentage, or residue of your estate once your family and friends have been considered. Your estate will receive a donation receipt for the value of your gift, reducing taxes payable on your final return.

Gift of Stocks or Securities

If you give a gift of appreciated stocks, bonds or mutual fund units to Waypoint, you will be 100% exempt from capital gains taxes, making this one of the easiest ways to give – and you'll receive a donation receipt for the value of the securities transferred.

Gift of RRSP/RRIFs

You can name Waypoint as a direct beneficiary of your RRSP, RRIF, or Canada Pension assets and receive tax benefits as a result. This type of gift will turn potential tax liabilities in your final tax return into a gift to support Waypoint.

Gift of Life Insurance

There are two main ways to make a gift of life insurance: you can name Waypoint as the beneficiary of an existing policy, or you can purchase a policy and name Waypoint as the owner and beneficiary of the policy. This type of donation allows you to make a sizable gift with only small annual or monthly payments. In addition, there is a tax credit available for immediate tax relief.

Did you know?



1 in 4 Ontarians will experience a mental health or addiction issue in their lifetime—yet many will never receive the care they need due to long wait times and lack of access to specialized services.



Mental health and addictions are the leading cause of disability in Ontario, costing the economy an estimated \$51 billion annually in health care, lost productivity, and social services.



Emergency room visits for youth aged 5 to 24 related to mental health have more than doubled in the past decade, highlighting the urgent need for early intervention and dedicated youth mental health services.



Suicide is the second leading cause of death among youth and young adults in Canada, and over 75% of mental health issues begin before age 25—underscoring the importance of early, sustained support like the programs offered at Waypoint.



Mental illness is common in later-life, with an estimated 1 in 4 older adults are living with a mental disorder (most commonly dementia, depression or anxiety). Rates are even higher in long-term care.



Waypoint Centre is one of only four specialized mental health hospitals in Ontario, and the only one serving Central and Northern Ontario. Your legacy gift helps ensure equitable, expert care reaches people in both urban and underserved rural communities.
